The sanction is subject to the following terms and conditions:-

1. The Dy. General Manager (FPSD) Jammu shall ensure that cost of timber alongwith taxes prevailing is received in the shape of Demand Draft in full as warranted under rules.
2. The Dy. General Manager (FPSD) SFC Jammu shall ensure that the consumers lift the timber strictly as per the release schedule given above.
3. The Dy. General Manager (FPSD), SFC shall issue individual case wise sanction on prescribed form alongwith Release Order/Bill is to be issued on the same day and the timber is to be ensured to be lifted by the consumers subsequently.
4. The timber sanctioned is to be released in favour of actual consumers only, and in some un-avoidable circumstances the same can be released in favour of duly authorised representative of the actual consumer.
5. The Dy. General Manager (FPSD), SFC shall ensure that the original Ration Card/Building permission is duly stamped at the time of release of the stocks.
6. In addition to the above, the conditions laid down in the individual sanctions to be issued subsequently issued by the Dy. General Manager (FPSD), SFC Jammu are also to be observed in letter and spirit is also entitled for the purpose.
